Despite Long Island's harshest winter in years, the construction project that began at Plant 10 in



September, 2020, is on schedule and on budget, with completion estimated for early September, 2021. This state-of-the-art Advanced Oxidation Process (AOP) for the treatment of 1,4-dioxane is a

\$6.2 million project which received \$3 million in funding from a New York State Water Infrastructure Improvement Grant.

Commissioner Joe Perry stated, "The work at Plant 10 was implemented to comply with new regulations required by the New York State Department of Health (NYSDOH), some of the most stringent in the nation. South Huntington Water District (SHWD) has proudly supplied the highest quality drinking water since 1925 and will continue to update its infrastructure to meet the new mandates."


We've been asked about the recent water treatment plant security breach in Florida. FYI, we use completely different software designed to prevent hacking.

MANDATORY ODD/EVEN IRRIGATION

When: Effective May 1, 2021 through
September 30, 2021.

- ▶ Even-numbered houses may water ONLY on even-numbered calendar days.
- ▶ Odd-numbered houses may water ONLY on odd-numbered calendar days.
- ▶ Houses without numbers may water ONLY on odd-numbered calendar days.

Notification: Please notify your irrigation contractors and landscapers to set watering times to the odd/even day schedule.




Honoring Our Heroes

"Knowledge is power," stated Commissioner Ciro DePalo. "We exist as an entity to ensure the good health of the public with a plentiful, uninterrupted supply of water that is compliant with all regulations. In an effort to be as transparent as possible, here are important facts about the District that some customers and residents may not know."

- Established: June 16, 1925
- Miles of water main: 271
- Service connections: Over 19,000
- Service area: Approximately 21.77 square miles
- Wells: 18 active wells, 16 with auxiliary power
- Pressure zones: 3
- Storage tanks: 7
- Interconnections: 13, with 6 neighboring water suppliers
- Fire hydrants: 1,715 in 6 fire districts
